### **1.0 CRITICAL CRITERIA**

- 1.0 The Learnership is registered with the Services Seta (NQF 4, number 23Q230008201204 & Qualification **ID 50080**). The Bidder must be registered with the relevant SETA. The Bidder must attach proof of its accreditation by a Sector Education Training Authority (SETA) as a Training Provider. The Bidder must complete Section 1A of the Compliance Certificate for the Critical Criteria as well as attach certified proof of accreditation by SETA.
- 2.0 The Bidder must attach a programme approval and /or provisional approval for the Project Management Learnership NQF Level 4 from the Services Seta in the bid Document. The Bidder must complete Section 1A of the Critical Criteria as well as attach a certified copy of a programme approval and/or provisional approval.

3.0 This Bid is a set aside for Black owned suppliers; preference will be

given to those companies that have a 30% Black female equity ownership and above. Please complete Section 1A of the Critical Criteria. The Bidder should complete Section 4 attach all supporting documents.

Set aside is a special condition that gives preference in the procuring of goods and services from Black suppliers. A Black supplier shall be a natural person or legal entity that is bonafide materially owned and controlled by South African Blacks, who are commercial active on an ongoing basis to add commercial value and is certified as such by Telkom. The Black owned supplier shall be a company that is 51 %( fifty one percent) and above owned and managed by Blacks. Black Management control shall mean Black Executive directors, managers, members including partners whom posses authority to change and influence material decisions in the business. These managers shall be actively involved in the daily operations of the business.

Blacks/PDI shall mean Africans, Coloureds, Indians, Black women and disabled people, excluding naturalised South Africans.
