### Scope:

Appointment of a single service provider to service and maintenance Mechanical Aids in the Gauteng, North Eastern and Central Regions. Bids of offers for only one specific region will also be considered. Bidders must provide Telkom with separate quoted prices per region.

### 1) Critical Criteria:

Bidders must comply with the following Critical Criteria to be considered for RFB 0016/08.

- A) Bidders must provide **proof** of a registered third party that will be used for the disposal of hazardous substances e.g. oil and diesel. The bidder must provide a valid third party contract or valid waste disposal certificate as proof.
- B) **Set aside** tender for fifty one percent (51%) and more Black Suppliers and preference given to a Supplier with thirty percent (30%) or more Black female equity ownership

### Definition: "SET ASIDE"

Set aside is a special condition that gives preference in the procuring of goods and services to Black suppliers. A black supplier shall be a natural person or legal entity that is bonafide materially owned and controlled by South African Blacks, who are commercially active on an ongoing basis to add commercial value and is certified as such by Telkom. The Black supplier shall be the company that is 51% and above owned and managed by Blacks. Black Management control shall mean Black Executive directors, managers, members including partners who possess authority to change and influence material decisions in the business. These managers shall be actively involved in the daily operations of the business. Preference will be given to the Service Provider/s that have a minimum of thirty percent (30%) or more Black female equity ownership.

**Note:** Proof of above two (2) requirements must be added to the compliance certificate.
