1.0 **SCOPE**:

Telkom wishes to invite potential bidder/s to bid for the Supply and Delivery of Sun Block to Telkom on a National Basis.

2.0 CRITICAL CRITERIA

The following critical criteria will be applicable to this bid. The bidders may be eliminated if they do not comply with the critical criteria.

2.1 Set aside tender for Black Suppliers

- Set aside is a special condition that gives preference in the procuring of goods and services to Black suppliers.
- A Black supplier shall be a legal entity that is bona fide materially owned and controlled by South African Blacks, who are commercially active on an ongoing basis to add commercial value and is certified as such by Telkom.
- The Black supplier shall be a legal entity that is 51% and above owned and managed by Blacks. Preference will be given to 15% Black Female shareholder/s.

2.2 Electronic Procurement

- The supplier must have the minimum of an Internet Connection with a Web browser or email.
- The supplier must agree to receive orders electronically.
- Confirm orders electronically by an order acknowledgment message.

2.3 Distribution Plan

- Supplier to submit an "End to End" distribution plan on how the deliveries will be executed to the person indicated on the delivery address
 - o From receipt of electronic to receipt of the Proof of Delivery.

2.4 Samples

- Bidders to submit samples
 - The Bidder shall supply twenty four (24) samples of all products offered with the RFB response for evaluation purposes.
 - o One control item will be kept.
 - o The other will be used for field trail purposes.
 - Once finalized, a set of control samples will be held by Telkom for reference and quality purposes.

2.5 SABS Certificate

 The Bidder must submit a SABS 1557 test certificate with the response to this RFB.
