Description:

The purpose of this request for tender (“RFB”) is to solicit tenders from interested parties (“Respondents”) to supply Telkom with Street Distribution Cabinets And Associated Components as well as Wall Mounted Security Distribution Point Boxes as specified in this RFB.

The Respondent will be expected to:

2.1 The SDC's and associated components and Wall Mounted Security Distribution Point Boxes shall be manufactured from 3CR12 corrosion resistant steel. Alternatives will not be considered. The thickness of the material shall be at least 1.6mm.

2.2 Each component shall undergo a pickling and passivation treatment after fabrication directly prior to powder coating.
