SCOPE:

Telkom wish to invite potential Bidder/s to bid for the supply and Commissioning/Implementation of Document Imaging and Lifecycle Management Solution.

CRITICAL CRITERIA:

The following critical criteria will be used to evaluate. Failure to comply with this criteria will result in automatic disqualification:

- 1.0 The solution shall provide a content management system to meet functions such as research, advertising and promotions, publishing, administration, resource management, HR, Finance, sales and Marketing enterprise application extension to suppliers and partners and customer self service.
- 2.0 The solution shall consist of a unified platform to provide a common set of core services for collecting, migrating, retaining, securing, and discovering all types of information content.
- 3.0 Store all content types including images, text and recordings within in the same database without silo's to separate data types.
- 4.0 Enable audit trails from the load stage to all future viewing.
- 5.0 The Load / Import process shall allow for bulk updating with sufficient intelligence to assign to a specific customer based on the Identification Number (ID) and/or details on scanned documentation.
- 6.0 The Original Equipment Manufacturer (OEM) SHALL have equity ownership in the Bidding entity".
- 7.0 The Bidder/s responding to this RFP, must have a Black shareholding of 25.1% or more effective shareholding in the company responding to this bid.

- 10.0 To prove the critical criteria, for the complete ECM solution, Telkom wishes to enter into field trials with short listed vendors at no cost to Telkom to item 1 to 8 above.
