1.0 SCOPE:

In terms of the Occupational Health and Safety Act, Act 85 of 1993, it is required of Telkom SA to provide personal protective wear to its employees. The purpose of this RFB is to obtain the services and product of supplier/s to supply Telkom personnel with Personal Protective Equipment (PPE) as per this Telkom bid. PPE includes protective clothing and footwear. The supplier is required to render an end-to-end service on a National Basis. Telkom reserves the rights to appoint a secondary supplier should the tender winner not perform against scope of work parameters.

2.0 CRITICAL CRITERIA

Bidders must meet the following critical criteria and requirements in order to be considered for the RFB:

2.1 Set aside tender for Black Suppliers

Set aside is a special condition that gives preference in the procuring of goods and services to Black suppliers. A black supplier shall be a legal entity that is bonafide materially owned and controlled by South African Blacks, who are commercial active on an ongoing basis to add commercial value and is certified as such by Telkom.

The Black supplier shall be a legal entity that is 51% and above owned and managed by Blacks. Preference will be given to Black Female shareholder/s

The bidding party must complete Section 4, Document 9, and Telkom's Black Economic Empowerment questionnaire and provide shareholders agreement, certificates, affidavits confirming Black ownership, and any other supporting legal documents, etc. The successful bidder/s would have to supply a BEE auditor's report to support the response to the BEE questionnaire in this RFB document.

2.1.2 Electronic Procurement

The supplier must have the minimum of an Internet Connection with a Web browser or email. The supplier must agree to receive orders electronically. The supplier must confirm orders electronically by order acknowledgement message.

2.1.3 Samples

- Supplier (s) to submit samples
 - Clothing, two of each item with bid documentation.
 - One control item will be kept
 - The other will be used for field trail
