Scope:

Open Bid for the provision of Working at Heights, Training and Related Equipment.

Pre-Qualification Criteria (Gate 1)

The following critical criteria will apply for evaluation of this RFB-00032-2013. Non-compliance to these criteria or no supporting documentation supplied with this RFB-00032-2013 response will invalidate your tender:

- As at the closing date of this RFB, the Respondent must have a valid B-BBEE recognition certificate issued by an approved IRBA registered auditor or a SANAS accredited verification agency. A valid IRBA or SANAS accredited certificate must be attached to the tender response.
 - If a Respondent qualifies as an Exempted Micro Enterprise (EME), a letter from its auditors or accounting officer must be submitted to verify accredited EME and percentage of black ownership as required in terms of B-BBEE legislation.
- 2) As at the closing date of this RFB, the Respondent must have a valid SARS Tax certificate. A valid SARS certificate must be attached to the tender response.
- 3) The Bidder's training equipment must conform to European standards maintained by CEN (European Committee for Standardization) EN Standards as outlined in Equipment Specification, paragraph 9 of the attached specification. Template letter of Agreement to be signed and submitted.
- 4) The required training program must be accredited by SAQA or IRATA Accreditation Body. The bidder must provide proof of valid accreditation certificate to be maintained by the Bidder up to the award of the Bid and contract duration.
- 5) The service provider must have the ability to provide both the Equipment, Equipment Kits, with separate items and Training service

- 6) The Bidder needs to comply with the Agreement on Occupational Health and Safety in Terms of Section 37.2 of the Occupational Health and Safety Act 85 of 1993 as amended. Template letter of Agreement to be signed and submitted
- 7) The Bidder must also provide a valid Letter of Good Standing from the Compensation Commissioner. The Letter of Good Standing must be valid on the closing date of the bid.
