## 1.0 CRITICAL CRITERIA

- 1.1 Experience of the accounting and statutory valuations of employee with the following benefit plans: Post retirement medical benefits; Share scheme; Pension fund; Retirement fund; valuation of share-based payments under both the BlackScholes and Binomial valuation techniques. Please provide a letter from the head actuary with details of a minimum of 10 companies with at least 1 company with an employee count of at least 10 000 employees. The letter must include contact persons and telephone numbers from these companies.
- 1.2 Provide a Company profile indicating detailed knowledge of the current International Financial Reporting Standards IAS19.
- 1.3 The firm must be registered with the Financial Services Board. A certificate would be required in this regard.
- 1.4 The firm must be registered as actuaries with the Faculty of Actuaries in South Africa. Documentary proof of current registration to be submitted.
