1. Critical Criteria

Potential Bidders must comply with the following critical criteria. Non-compliance to any one of these criteria and no supporting documentation supplied, e.g. municipal account, with the RFB response for any one of the critical criteria will invalidate your bid.

1.1	The bidder must submit a certified letter confirming that their company is in full compliance with the Fire Arms Control Act. 60 of 2000. In addition the bidder must submit a letter of confirmation by the Firearms Authority (SAPS) that indicates the list of registered and licensed firearms in the bidder's possession.
1.2 a)	The bidder shall have fully functional, operational and manned Control Room/s as per page 16, paragraph 17 of the requirements for Control Room in the specification (attached). Such Control Room/s or premises shall be in accordance with the Private Security Industry Regulatory Authority (PSIRA) Act 56 of 2001. Supporting documentation in the form of proof of ownership/valid lease/rental or bond agreement must be provided by the bidder. All documentation provided must be in the bidders registered company name. The lease/rental agreement must be valid until 31 October 2011.
1.2 b)	The bidder must provide their three most recent municipal accounts e.g. electricity/water bill, in the bidders registered company name, which may not be older than 01 October 2010 with the tender response. This must be done for each lease/bond agreement submitted. If, the municipal account is not in the name of the bidder then the other accounts relevant to this premises that is in the name of the Bidder must be submitted with the Tender response.

1.3	The bidder must submit an original Private Security Industry Regulatory Authority (PSIRA) Letter of Good Standing, which must be valid at the time of the bid.
1.4 a)	The bidder shall have fully functional and operational office/s for the regions which they are bidding for. Such premises shall be in accordance with the Private Security Industry Regulatory Authority (PSIRA) Act 56 of 2001. Supporting documentation in the form of proof of ownership/valid lease/rental or bond agreement must be provided by the bidder. All documentation provided must be in the bidders registered company name. The lease/rental agreement must be valid until 31 October 2011.
1.4 b)	The bidder must provide their three most recent municipal accounts e.g. electricity/water bill, in the bidders registered company name, which may not be older than 01 October 2010 with the tender response. This must be done for each lease/bond agreement submitted. If, the municipal account is not in the name of the bidder then the other accounts relevant to this premises that is in the name of the Bidder must be submitted with the Tender response.
1.5	The bidder must have Effective Black Ownership of 51 % or more. The Bidder must complete the BEE Questionnaire and provide the applicable documentation to substantiate or proof compliance to the critical criteria. The bidder must provide a signed statement through their Auditors that their effective Black Shareholding of 51% has been valid for the past six months.
1.6	The Bidder must complete and sign the 3 rd Party Prevention & Combating of Corrupt Activities Questionnaire. This is provided in the RFB document, Volume 1, Part 17.
