RFI 103/04	<p><u>DESCRIPTION:</u></p> <p>Telkom Requests Information for Broadband Wireless Access (BWA)</p> <p><u>SCOPE:</u></p> <ul style="list-style-type: none"> a. In recent times, broadband wireless access standards such as the IEEE 802.16 standard, which defines the air interface and MAC protocol for a wireless metropolitan area network (Wireless MAN), have become commercial reality. It is the purpose of this Request for Information to gather as much information as possible on all broadband wireless access technologies and related customer premises equipment for all appropriate market and service segments. b. Telkom SA has a preference for standards based technologies intended for broadband wireless with voice and data capabilities for residential and enterprise use. These standards referred to are inclusive of, but not limited to IEEE 802.16a/d/e/2004/f/g, IEEE 802.20, IEEE 802.21 (and subsequent standards) as well as ETSI's HiperMAN standard. 3G/UMTS, and CDMA 2000 1x solutions do not form part of this RFI, but interoperability of broadband wireless systems and these technologies is however referred to. This is not to say that non-standards based BWA solution will not be entertained, on the contrary, should a technical solution provide a sound and superior business case, then by all means the technology should be considered. c. Since BWA competes with other technologies like DSL, low cost will be essential for the success of BWA adoption. Interoperable standards will enable economies of scale to be reached resulting in lower equipment costs and reduced investment risk. Operators require the flexibility to deploy equipment from multiple vendors as the need arises in order not to be dependable on one manufacturer and proprietary systems. d. For purposes of this RFI, frequency bands between 2GHz and 11 GHz will only be covered. Specific information regarding the frequency management is given within this document. e. Harmonisation is a significant driver for standardisation, especially to achieve economies of scale and interoperability between operators, service providers and across international boundaries. Frequency spectrum alignment and standards adoption is necessary for harmonisation to succeed. f.
