6.1.1	At the Closing Date of the Bid, the Bidder must have a valid B-BBEE Recognition Certificate evidencing a minimum level 4 (four) or better BEE status issued by an approved IRBA registered auditor or SANAS accredited verification agency. Companies with annual turnover of less than R5 m: A letter from Independent Auditors/Accountant confirming the company's annual turnover and the percentage (%) of effective Black shareholding in the company is required. Bidder to attach a valid IRBA or SANAS accredited certificate to the bid response.
6.1.2	The Bidder must have a valid TAX Clearance Certificate from SARS at the close of Bid Bidder to submit valid TAX Clearance Certificate from SARS

6.1.3	The bidding agency must have no current contract(s) with MTN, Vodacom, Cell C and Neotel on any related scope of work for this tender (Integrated Employee Engagement Programme) on the closing date of this tender. Bidders to provide the name of the corporate, details of the project, as well as the contactable reference for this account to substantiate compliance.
