#### **Description:**

The purpose of this request for tender ("RFP") is to solicit tenders from interested parties ("Respondents") to supply Telkom with Outdoor Distribution Point Boxes For Copper Subscriber Cables as specified in this RFP.

- 2.2 The <u>20 Pair DP box</u> shall be equipped with:
  - 2.2.1 1 x 2-way Krone type mounting frame (22.5mm pitch)
  - 2.2.2 Two-glands for cable entry shall make provision for the entrance of up to 1 x 100 pair cable each.
  - 2.2.3 A separate multiport gland for drop wire entrance.
- 2.3 The <u>50 Pair DP box</u> shall be equipped with:
  - 2.3.1 1 x 5-way and 1 x 2-way Krone-type mounting frames (22.5mm pitch). The 5way frame shall be mounted in the top portion of the DP Box, and the 2-way frame shall be mounted in the bottom portion of the DP Box.
  - 2.3.2 Three glands for cable entry shall make provision for the entrance of up to 1 x 100 pair cable each.
  - 2.3.3 A separate multi port gland for drop wire entrance.
- 2.4 The <u>100 Pair DP box</u> shall be equipped with:
  - 2.4.1 1 x 10-way standard Krone-type mounting frame (22.5mm pitch)
  - 2.4.2 1 x 3-way standard Krone-type mounting frame (22.5mm pitch)
  - 2.4.3 Four glands for cable entry shall make provision for the entrance of up to 1 x 100 pair cable each.
  - 2.4.4 A separate multi port gland for drop wire entrance.
- 2.5 To allow for the looping of cables in and out of the DP Box the base shall be manufactured in two parts (split base) separating it at a point in a centre line with the cable ports. The two parts shall be joined together by means of suitable fasteners. If threaded fasteners are used, the nut (threaded insert) shall be permanently attached to the main body.
