Telkom wish to invite potential Bidder/s to bid for the Revenue Assurance Solution (RAS).

CRITICAL CRITERIA:

The following critical criteria will be used to evaluate. Failure to comply with this criteria will result in automatic disqualification:

- 1.0. The Vendor shall have at least 3 implementation at Tier 1 Telco's globally
- 2.0. The solution shall have open API's (Application Programming Interface) conforming to Telkom specification 1856.
- 3.0. The vendor shall have proven end to end solution intergration experience within the complete ICT (Information and Communication Technology) environment.
- 4.0. The Bidder/s must have effective Black shareholding of 25.1% or more in the company responding to RFP.

Note: In order to qualify for the Critical Criteria number 3.0 and 4.0 above:

- Share certificate
- Shareholders agreement
- Registration documents
- Proof of shareholding by the OEM in the bidding company and
- Proof of South African citizenship by Shareholders
