Critical Criteria

The following Technical & Commercial Critical Criteria will be used to evaluate the proposals:

Commercial

Potential bidders have to comply with the following critical criteria. Non-compliance to any one of these criteria or no supporting documentation supplied, i.e. SARS certificate, with the RFP response for any one of the criteria may invalidate a bid.

The following requirements are regarded as Critical Criteria:

- (a) The offered solution shall be able to provide an integrated Audio and Web Conference solution, with a minimum of 1100 SIP audio conference ports, which has been deployed commercially prior to this tender.

Support your answer by:

Providing a diagram of the solution.

Providing references of customers.

Per customer, providing the number of installations and number of ports per installation.

(b) The offered solution shall have the ability to allocate capacity and features, supporting multiple Audio and Web Conference products.

Support your answer with reference sites and examples of products launched.

(c) The offered solution shall be fully compliant to RFC 3261 SIP signalling.

Support your answer by:

Providing a point-to-point Statement of Compliance to RFC 3261.

(d) The solution shall be able to perform its intended functions within a segregated IP network. Segregation can be via Firewalls, Session Border Controllers (SBC) and Reverse Proxy Servers, depending on the network configuration, and span over multiple networks.

Support your answer by:

Providing a diagram of different installation configurations, highlighting the solution's segregation capabilities.

Failure to comply with the above critical criteria will result into elimination of the Proposer from the RFP process.
