SCOPE:

The purpose of this RFP is to acquire a service provider to provide Telkom Mobile's requirements for an efficient 2G and 3G, Voice and Data, Drive Test, Post-processing and Reporting Service to validate and benchmark its mobile voice and data network.

CRITICAL CRITERIA RFP0301/2010:

#	CRITICAL CRITERIA: Potential Bidders have to comply with the following critical criteria. Non-compliance to any one of these criteria will invalidate a bid. Proof of evidence must be supplied with each of these criteria:
1	TECHNICAL CRITICAL CRITERIA
	The Service Provider SHALL provide a complete Drive Test, Post Processing and Report Generation service.
2	TECHNICAL CRITICAL CRITERIA
	The Bidder must be able to prove by performing the physical drive test upon one week request from Telkom.
	The testing of the Service Provider shall demonstrate the quality assurance methods by which the equipment consistency will be tracked. It is a requirement that the test vehicle used for the field measurements completes an equipment verification checks and quality acceptance tests at approved Telkom inspection facilities to ensure equipment is calibrated and approved prior to usage.

	The Service Provider will be required to perform field measurement test equipment quality testing, and complete a field measurement tests within a specific small area located within South Africa, together with Telkom, the purpose of which is to confirm that the equipment and setup is within the range of expected results.
3	TECHNICAL CRITICAL CRITERIA
	The Service Provider SHALL provide all the necessary tools and equipment to undertake the delivery of the service, both in terms of data collection, data processing, and reporting. The Service Provider SHALL provide documented proof of the tools and licenses of the tools that they will be using.
4	BLACK ECONOMIC EMPOWERMENT
4.1	Telkom requires that all bidders must have a minimum of 25.1% Effective Black Shareholding/equity ownership. The Bidder must complete the BEE questionnaire in the RFP document and provide all the documents as stated below. Companies with complex shareholding structures should provide a detailed shareholding structure highlighting the effective shareholding of the Blacks in all the different entities where they have indicated black shareholding in section 1 of the questionnaire. Failure to complete the BEE questionnaire and to provide all documents as requested in this paragraph will be taken as non compliance to this critical criterion.
4.2	Bidders are further requested to submit their latest Verification certificates.
5	COMMERCIAL
	The bidder responding to this RFP must supply a tax compliant certificate from SARS which must not be older than 3 months.
