SCOPE:

Telkom wish to invite potential Bidder/s to bid for the Enterprise Risk Management (ERM).

CRITICAL CRITERIA:

The following critical criteria will be used to evaluate. Failure to comply with this criteria will result in automatic disqualification:

- 1.0. The solution must provide for local maintenance and development support Including local support structures (head office and / or satellite offices) and the availability of dedicated resources (onsite and telephonically or online) for the time zones affected across the Telkom Group.
- 2.0. The solution must provide the capability to facilitate Governance, Risk and Compliance management.
- 3.0. The solution must allow for the assessment, management and monitoring of any risk, control, event or compliance item by using multiple frameworks (methodologies) that can be aligned to standards(ISO31000, COSO, COCO, COBIT, KING II / III, Tumbill).
- 4.0. The solution must provide the capacity to facilitate import and export functionality to various third party applications which include MS Excel and Acrobat.
- 5.0. The solution must provide the capability to facilitate automated workflow to notify (Via e-mail) and escalate risks to risk owners and control to control owners triggered by events.
- 6.0. The solution must perform high level reporting functionality that must include dashboard, drill down, slice and dice, web, graphical, interactive and multiple currencies
 - Customise reports for different users, i.e. the board , management and operations
 - Customise reporting filters and groupings

- 7.0. The solution must offer both, rich and web client platforms (refer to requirements in the RFP specification (Spec 2409)
- 8.0. The solution must have the functionality to accommodate the synchronisation of data captured offline.
- 9.0 To prove the critical criteria, for the complete ERM solution, Telkom wishes to enter into field trials with short listed vendors at no cost to Telkom.
