1.0 SCOPE:

KVM refers to "Keyboard, Video and Mouse." These three items are collectively known as KVM Console. KVM Switch enables a single KVM Console to connect to multiple devices allowing users to access and control multiple PC's and Servers from a single console. KVM is a strategic technology to assist Telkom in reducing Mean time to repair (MTTR) as it enables staff to have centralized and secure remote access to all remote server farms and network appliances down to the hardware level. Fault localization and resolution is substantially faster.

Vendors are required to provide Telkom with such a solution.

2.0 Critical criteria

Vendors need to meet the following critical criteria in order to be considered for the RFP:

2.1 Technical requirements

Multi Platform Support

The KVM solution shall be able to support all server platforms and network devices in Telkom SA without the need to implement 3rd party solution regardless the OS or hardware or the target server.

Data Encryption

The KVM system shall encrypt the Keyboard, Video and Mouse signals with adequate encryption schemes such as 128-bit SSL.

Access Control

The solution shall provide support connection to Telkom SA Active Directory AA server and shall support other AA servers such as LDAP and RADIUS.

2.2 Special Bid condition

Although BEE will not be included in the Critical criteria, Telkom will give first preference to Respondents within a minimum of 30% Effective Black Female Shareholding, followed by Respondents with a minimum of 25.1% Effective Black Shareholding in the adjudication of this RFP.
