1.0 **Description:**

Telkom wish to invite potential Bidder/s to bid for the Rental of Dispensers, Supply and the Delivery of Bottled Water to Telkom.

2.0 **CRITICAL CRITERIA REQUIREMENTS:**

The following critical criteria will apply for evaluation of this RFB. Non-compliance to these criteria or no supporting documentation supplied with this RFB 00010/2013 response will invalidate your tender:

2.1 **BB-BEE recognition Level 4 (four) or better**

At the Closing Date of the tender, the Respondents must have a valid BB-BEE Recognition Certificate evidencing a minimum level 4 (four) or better BEE status issued by an approved IRBA registered auditor or SANAS accredited verification agency. A valid IRBA or SANAS accredited certificate must be attached to the tender response.

ONLY VALID IRBA OR SANAS ACCREDITED CERTIFICATES WILL BE ACCEPTED AS PROOF OF BB-BEE STATUS

Complies with annual turnover of less than R5m: A letter from Independent Auditor/Accountant confirming the company's annual turnover and the percentage (%) of effective Black shareholding in the company is required. A valid Independent Auditor/Accountant letter must be attached to the bid response.

2.2 **Tax clearance certificate**

The Bidder shall provide a valid SARS Tax certificate and it needs to be maintained by the Bidder up to the award of the Bid.

2.3 The Bidder shall provide an independent laboratory Test Report proving compliance to SANS 241 standard. The Report shall not be older than twelve (12) months on the date that the Bid closed. The bidder must provide evidence in a form of a certificate from SABS (South African Bureau of Standard) or any other accredited agency.
