# 1.0 SCOPE:

- Supply recent client list for the past 24 months. Specify the following regarding all the clients on the list where a corporate or business service has been rendered:
  - Date on which the contract was awarded
  - Duration of the contract

- Contact name(s) with contact details (telephone number and email address) for each contract
- The proposer should be able to visit Telkom offices in Pretoria at short notice in an emergency. This means the proposer is required to commit being on site within 24 hours in emergency situations.
- **Provide examples** of what is proposed from existing shops/projects you are currently involved with.

# The following should be included:

- Electronic catalogue/Paper catalogues
- Ordering process
- Proposer's financial statements for financial year 2009/2010
- Marketing material examples of adverts/posters done
- Examples of special promotions done

Supply three (3) samples of the applicable items for evaluation along with the proposal response. Refer to Appendix A for detail. The quality of the items must be appropriate to the image that a Corporate Company wishes to be associated with. The proposer is to also supply a Catalogue of other items they propose to offer along with the prices as per the price categories indicated in Appendix A.
