Critical Criteria

Potential Bidders have to comply with the following critical criteria. Non-compliance to any one of these criteria or no supporting document supplied with the RFP response for any one of the criteria will invalidate a bid.

1. Black Economic Empowerment

The bidder must have a minimum 25.1% or more effective black shareholding.
Bidder to provide the following applicable documentation to substantiate compliance to the critical criteria:
<ul style="list-style-type: none">• Shareholders agreement.
<ul style="list-style-type: none">• Share certificates.
<ul style="list-style-type: none">• Detailed verification of your company's BBBEE including affidavit/s verifying and/or confirming black shareholding in the company.
<ul style="list-style-type: none">• A letter from internal Auditors confirming level of unrestricted entitlement of black people to receive their economic interest.
<ul style="list-style-type: none">• And any other legal document that proves detailed black ownership of the company.
<ul style="list-style-type: none">• Joint Ventures shall be legally registered entities.

2. Technical

- 2.1 The POTS interface shall conform to the DC feed Characteristics and input impedance specifications as per SP2461 Paragraph 7.2.2 a (ii) and (iii). Supporting document needs to be provided. Suitable supporting documentation would include, equipment specifications, equipment manuals or test reports.
- 2.2 The MSAN shall support BRI, ADSL2+ and SHDSL.bis interfaces as per SP-2461 Paragraph 6.2.1 a (ii), 6.2.1 a (x) and 7.2.4 a. Supporting document needs to be provided. Suitable supporting documentation would include, equipment specifications, equipment manuals or test reports.
- 2.3 The EMS must have a single North Bound interface that exposes all functionality; Fault, Configuration, Performance and Security Management of the EMS system as per SP-2066 Paragraph 3.2.6. The above criteria shall be supported by the configuration manuals of the EMS system.
