Critical Criteria

The following Critical Criteria will be used to evaluate the proposals:

1. Courier Services registration certificate for unreserved postal services

“Prohibition on operating unreserved postal service without registration certificate

20. No person may operate an unreserved postal service contemplated in Schedule 2, unless such person is registered with the Regulator in terms of the Act and is in possession of a registration certificate issued by the Regulator.”

The Bidder/s **must provide a certified copy of their registration certificate issued by the Regulator**, as specified in the Postal services Act no.124, 1998.
