Potential Bidders have to comply with the following critical criteria. Non-compliance to any one of these criteria or no supporting documentation supplied, with the RFP response for any one of the criteria will invalidate a bid.

1.0 Black Economic Empowerment

Telkom requires that proposers/bidders must have a minimum effective Black Ownership of of level 4.

The bidder must be a minimum Level 4 Contributor with a valid certificate at the close of the bid

Bidder must provide a valid certificate issued by a SANAS approved rating agency

2.0 Safety Health and Environment (SHE)

1. In terms of the Construction Regulations 2003 and the Telkom Section 37.2 Agreement, the bidder shall agree to be appointed by Telkom as an "Agent" and there to execute the requirements of the said appointment.
 - a) Statement of Compliance.
 - i. The bidder shall sign the Telkom Section 37.2 Agreement where required.
 - ii. The bidder shall complete and sign the document provided, (SHE 15.1a)

2. In terms of the Compensation Injuries Occupational Diseases Act, Chapter IX, the bidder shall submit a valid Letter of Good Standing from the Workmen's Compensation Commissioner.
 - a) Statement of Compliance
 - i. The bidder shall complete and sign the documents provided
 - ii. The bidder shall submit the valid Letter of Good Standing from the Workmen's Compensation.

3.0 Technical

1. The bidder must have RAN Build experience: The Service Provider shall provide proof of RAN build projects completed (description, location, customer and value) within the last 24 months. It is required of the Service Provider to provide a confirmation letter from the customer confirming the RAN build service delivery on a customer letterhead.

2. This Build Scope of Service (BSOS) will include roll out of RAN's on a national basis but will focus primarily on the Telkom regional areas below. The Service Provider shall indicate if it has the capability to service all the following regions:
- Gauteng Central (Gauteng), and
 - North Eastern (Gauteng, Mpumalanga, Limpopo, North-West, Free State), and
 - Eastern (KwaZulu Natal)
