1. Critical Criteria

Potential Bidders must comply with the following critical criteria. Non compliance to any one of these criteria and no supporting documentation supplied with the RFP response with any one of the critical criteria will invalidate your Bid.

1.1 Technical Specification

1.1.1 The Bidder must be experienced and qualified in CIT and Bulk Cash Handling and have the existing infrastructure to perform the end-to-end Coin Management functions that meet security and CIT Industry norms according to the approved legislation. The following must be provided:

I. CIT

1. The Bidder must submit a copy of the PSIRA certificate of all their directors, members and/or partners of their company or trustees to confirm PSIRA registration.
2. The Bidder must also provide a PSIRA letter of good standing for the past year.
3. The Bidder must provide copies of proof of ownership/lease/rental agreements for CIT vehicles.

II. Bulk Cash Handling

1. The Bidder must provide copies of a letter from at least one company they are currently contracted to, confirming duration of the contract between them.

III. Equipment and Buildings

1. The Bidder must provide copies of proof of ownership/lease/rental agreements for equipment and buildings.

1.2 Black Economic Empowerment (BEE)

1.2.1 At the closing date of the Bid, the Bidder must have a valid B-BBEE recognition certificate evidencing a minimum level 4 (four) or better BEE status issued by a SANAS accredited verification agency. A valid SANAS accredited certificate must be attached to the Bid response.

ONLY VALID SANAS ACCREDITED CERTIFICATES WILL BE ACCEPTED AS PROOF OF B-BBEE STATUS.
