# 1. Pre-Qualification Criteria (Phase 1)

### 1.1 Tax clearance

At the closing date of this RFPr, the bidder should provide Telkom with a valid original SARS tax clearance certificate. This certificate should be attached to the RFPr response.

### 1.2 Telkom Terms and Conditions

Bidders must accept Telkom's Master Service Agreement and Annexure for "Services".

# 1.3 Availability and capability

The bidder must confirm their availability and capability to start on 10 September 2014 and provide confirmation that dedicated resources are available to manage the Telkom account.

## 1.4 Experience

- (i) Bidders must provide evidence that they have made at least **15 permanent placements** on Executive and higher levels. This refers to the following organizational levels on the grading systems:
  - Telkom levels M3 (Executive) level and higher which is Managing/Group Executive, Managing Director etc.
  - o Patterson system E levels and higher
  - Hay system equal to 735 to 1,260 points and higher.

- (ii) These permanent placements must have taken place in large companies consisting of 1,000 employees and more.
- (iii) The placements must have been undertaken during the previous two years, namely 1 August 2012 to the closing date of this Request for Pricing.
