OPEN TENDER/e-RFP 00006/2014 FOR THE APPOINTMENT OF TELKOM HEAD OFFICE PANEL OF ATTORNEYS: SECTION B FIRMS

This is an e-RFP whereby respondents need to register to gain access to the tender. A respondent needs to complete and submit a supplier registration form to Telkom's contact person. See paragraph 2 below.

GENERAL

1. Bidders Conference:

A bidder's conference (not compulsory) will be held at 152 Johannes Ramokhoase Street, Telkom Towers North. 1st Floor Strelitzia conference room. Date of Bidder's Conference: 28 February 2014, time 10:30 am.

2. Bid Document Collection

Please note that this is an e-RFP and respondents need to complete and submit "**Telkom's Supplier Self-Registration**" access form (See at the end of this document) to the following e-mail address.

3. Minimum system requirements for electronic access

For internet access the Respondent(s) need to have 1 (one) computer connected to the Internet with 1 (one) back-up system. The following system requirements per computer:

- 3.1 Microsoft Internet Explorer 6 SP2, or 7, or 8
- 3.2 Microsoft Office 2007 or higher
- 3.3 SAP Sourcing also supports Microsoft Office 2003
- 3.4 Adobe Reader 9.3 or higher



4. Tender information

Once the Respondent has been given access to the e-RFP, the Respondent applying for this Section must complete as per e-RFP the following 3 (three) parts.

PART 1: PRE-QUALIFICATION CRITERIA: SECTION B FIRMS

Respondents must submit supporting documentation with the following pre-qualification criteria. Non-submission of supporting documentation may result in disqualification.

1) As at the closing date of this e-RFP, the Respondent must have a valid SARS Tax certificate.

A valid SARS certificate or certified copy must be attached to the tender response.

2) A respondent will be classified as a section B firm if it has no less than 25 and no more than 49 partners and/or directors at the closing date of the e-RFP.

A letter from the firm's independent auditor or an affidavit by the senior partner or director of the firm confirming the requirement must be submitted with the tender response. The respondent must submit an original signed document.

3) A Section B firm must have at least 10 partners and/or directors with 10 years or more experience in their field of expertise at the closing date of the e-RFP.

A letter from the firm's independent auditor or an affidavit by the senior partner or director of the firm confirming the requirement must be submitted with the tender response. The respondent must submit an original signed document.

4) The respondent's head office (main place of business) must be located within a radius of 75 kilometers from Telkom's head office (152 Johannes Ramokhoase Street, Pretoria).

A letter from the firm's independent auditor or an affidavit by the senior partner or director of the firm confirming the requirement must be submitted with the tender response. The respondent must submit an original signed document.

- 5) As at the closing date of this e-RFP the respondent must have at least the following resources and infrastructure available:
 - i. Computer(s), e-mail and internet access.
 - ii. Software applications used in the legal practice to provide legal services to clients.
 - iii. Information security safeguards (i.e. antivirus software, software, firewalls etc.)
 - iv. Back-up and disaster recovery plans.
 - v. Telephone and fax facilities.
 - vi. Printing and photocopying facilities.
 - vii. Library/research facilities.

A letter from the firm's independent auditor or an affidavit by the senior partner or director of the firm confirming the requirement must be submitted with the tender response. The respondent must submit an original signed document.



6) At the closing date of this e-RFP, the partners and/or directors of the Respondent must have a valid Fidelity Fund certificate.

A letter from the firm's independent auditor or an affidavit by the senior partner or director of the firm confirming the requirement must be submitted with the tender response. The respondent must submit an original signed document.

7) At the closing date of the e-RFP the firm must be in good standing with the Law Society which reflects that the firm has paid its annual levies and is not subject to any disciplinary action by the Law Society.

A respondent must submit a letter of good standing from the Law Society.

- 8) At the closing of this e-RFP, a respondent must complete and submit the following documents:
 - i. Pro Forma authority for signatory.
 - ii. Declaration by Respondent
- iii. Telkom law firm guidelines
- iv. Declaration of Interest
- v. Telkom's supplier code of conduct
- vi. Taxation questionnaire and declaration
- vii. Prevention of fraud & corruption questionnaire
- viii. Legal Agreement to provide services

PART 2: PRICING INSTRUCTIONS TO THE BIDDERS - SECTION B FIRMS

- Pricing must be firm and fixed for the first twelve (12) months of the contract period. Firm
 prices are deemed to be the prices at which the service/s are rendered without any
 adjustments being made thereto over the first twelve (12) months of the contract period
 for any reason whatsoever. The prices may be reviewed and negotiated for the second
 twelve (12) months of the contract period.
- 2. The prices quoted by Bidder and negotiated by Telkom will form the contract prices and no changes or increases will be allowed by Telkom for incorrect information supplied by the Bidder.
- 3. A respondent firm that qualifies for Section B must submit a response for <u>all</u> work categories 1 to 5 of the attached costing spreadsheets. Work Categories 1 to 5 are compulsory. All areas highlighted in blue needs to be populated.
- 4. Respondents will be allowed to deviate from the proposed Telkom rates set out per category. However, any such deviation, for each level of experience, as well as action required as set per category, may not be higher than 30% of the proposed Telkom rates.
- 5. A Respondent will automatically be disqualified per work category, if any of its proposed rates are more than 30% of the proposed Telkom rates for such work category.



- 6. However, a Respondent firm in Section B will automatically be disqualified for all the compulsory work categories 1 to 5 if any of its proposed rates for any of the work categories 1 to 5 are more than 30% of the proposed Telkom rates. Therefore the entire tender for Section B will be disqualified.
- 7. Respondents will be ranked or scored (for section B) according to the overall fee per category and then the overall combined group of categories 1 to 5 for their proposed rates.
- 8. Respondents must note that the percentage increase required for the second (2nd) year of the contract will be negotiated. The cost for the second (2nd) year of the contract will also remain fixed after being negotiated and mutually agreed upon by the Parties.
- 9. Failure to submit the required Pricing spreadsheet documentation will result in service providers scoring zero.
- 10. All fees should be exclusive of VAT.

PART 3: BEE INSTRUCTIONS TO RESPONDENTS: SECTION B FIRMS

As at the closing date of this RFP, the Respondent must have a valid B-BBEE recognition certificate issued by an approved IRBA registered auditor or a SANAS accredited verification agency. A valid IRBA or SANAS accredited certificate must be attached to the tender response.

If a Respondent qualifies as an Exempted Micro Enterprise (EME), a letter from its auditors or accounting officer must be submitted to verify accredited EME and percentage of black ownership as required in terms of B-BBEE legislation.

Failure to submit the required B-BBEE documentation will result in the Respondent scoring zero for B-BBEE, Black Economic Empowerment (10 points) below.
