1 How to enter

2 Selection of winners

2.1 1 (One) winner will be selected randomly via the Telkom competition engine. Entry into the competition will be SUBJECT TO SUCCESSFUL CREDIT VETTING by Telkom. All entries must originate from one successful order activation.

2.2 The winner will be chosen by Telkom and the results will be audited appropriately.

3 Entry requirements

3.1 How to enter:

- Entrants must visit the site: <http://tbc> and complete the order form for the new Huawei P9 phone with the relevant details required.
- Entry into the competition will be SUBJECT TO SUCCESSFUL CREDIT VETTING by Telkom.
- Once the qualifying entrant has fulfilled the requirements above, he or she will be automatically entered into the lucky draw.

3.2 Who is eligible to enter?

- A natural person
- An existing or new Telkom mobile Consumer subscriber
- A South African citizen or a permanent resident with a valid South African identity document; and
- A person 18 (eighteen) years or older.

3.3 Who is not eligible to enter?

- Telkom employees and associated family and friends
- Telkom vendors and customer partners
- Minors under the age of 18

3.4 What are the selection criteria?

- Only entrants who have participated by ordering a Huawei P9 from Telkom's website and are subject to successful credit vetting by Telkom are eligible to be entered into the draw.
- The winner will be chosen by Telkom and the results will be audited appropriately.
- Entrants must be active on the Telkom mobile network and using the Huawei P9 device at the time of the draw.
- The winner will be selected from all entries received randomly within the competition period by Telkom and the results will be audited appropriately. Telkom's decision is final and no correspondence will be entered into.
- The winner will be notified telephonically by the Telkom and/or its authorized agents on or as soon as possible after the draw. The winner will be subject to an allocated time period of 24 hours to accept or reject the prize. The winner will need to respond with their requested details within 7 working days of being notified in order to receive their prize
- The winner's prize will be will be delivered to them within 14 (fourteen) days after responding with their requested details. The winner will be contacted and will need to confirm their requested details. Should Telkom not receive a response from the winner in the said allocated time period, the prize will be transferred to the next randomly selected winner whose response is in accordance with the stated time-frame.
