

# Telkom Netball League: Competition Terms & Conditions

**April 2024**

1. The competition is run by Telkom SA SOC Ltd (“Telkom”) (Registration Number 1991/005476/30), a listed company duly incorporated in accordance with the laws of the Republic of South Africa, with its registered address at Telkom Park, the Hub, 61 Oak Avenue, Techno Park Highveld Centurion, Pretoria (“Telkom”) including its affiliates, partners, associations and agents (“the Organiser”).

## **2. Eligibility**

2.1 The competition is open to South Africans with an ID book/card and aged eighteen (18) years or older.

2.2. The participant should be an active Telkom Mobile Prepaid customer.

2.3 Telkom employees and its subsidiaries and/or, employees and their immediate families as well as Telkom’s advertising and promotion agencies, distribution partners, associated companies, and outlet owners, dealers, resellers and their immediate families and employees are excluded from participating in this competition.

3. The Organiser reserves the right to amend the rules by reasonable notification at any time during the competition and will be applied and interpreted at the sole discretion of the Organiser.

Participation by the entrants constitutes acceptance of these rules.

5.1 In order to enter the competition customer needs to recharge and/or spend R25 or more cumulatively on a weekly basis; by purchasing a mobile prepaid Data, Voice, LTE bundle and/or integrated bundles (i.e. prepaid bundles made up of a combination of the following: voice + data + SMS) on \*180#, \*123# or via any other platform

### **5.2 terms and Conditions:**

5.2.1 The competition is open to both new and existing Telkom customers who purchase Prepaid bundles. To qualify, customers are required to recharge and spend R25 or more weekly; by purchasing their favourite Prepaid bundles.

5.2.3 Entries received after the closing date of the campaign will not be considered

5.3.1 Participants will stand a chance to win **6 of 360 tickets** to the Telkom Netball league matches for every qualifying entry:
